During this Faculty Development Programme, we targeted on the following topics:-

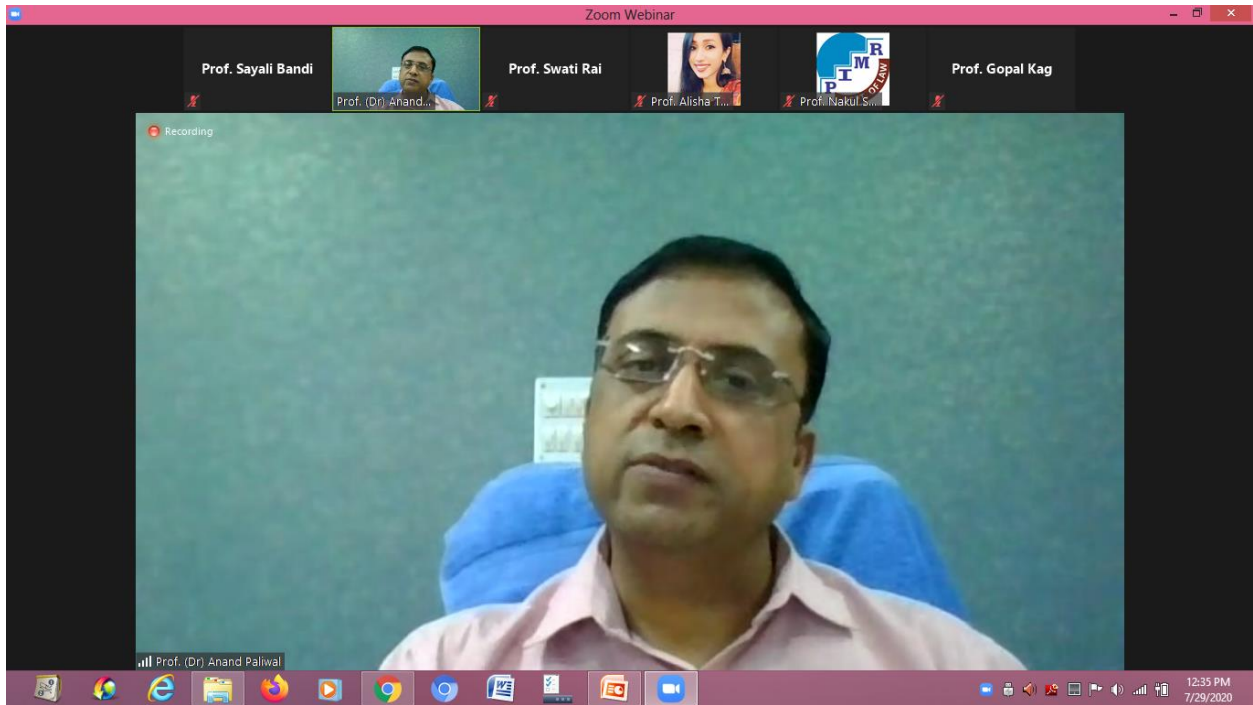
1. Conducting International Commercial Arbitration

Experts in the field from academia as well as advocacy will be invited as Resource Person. The Resource Persons invited were as following: -

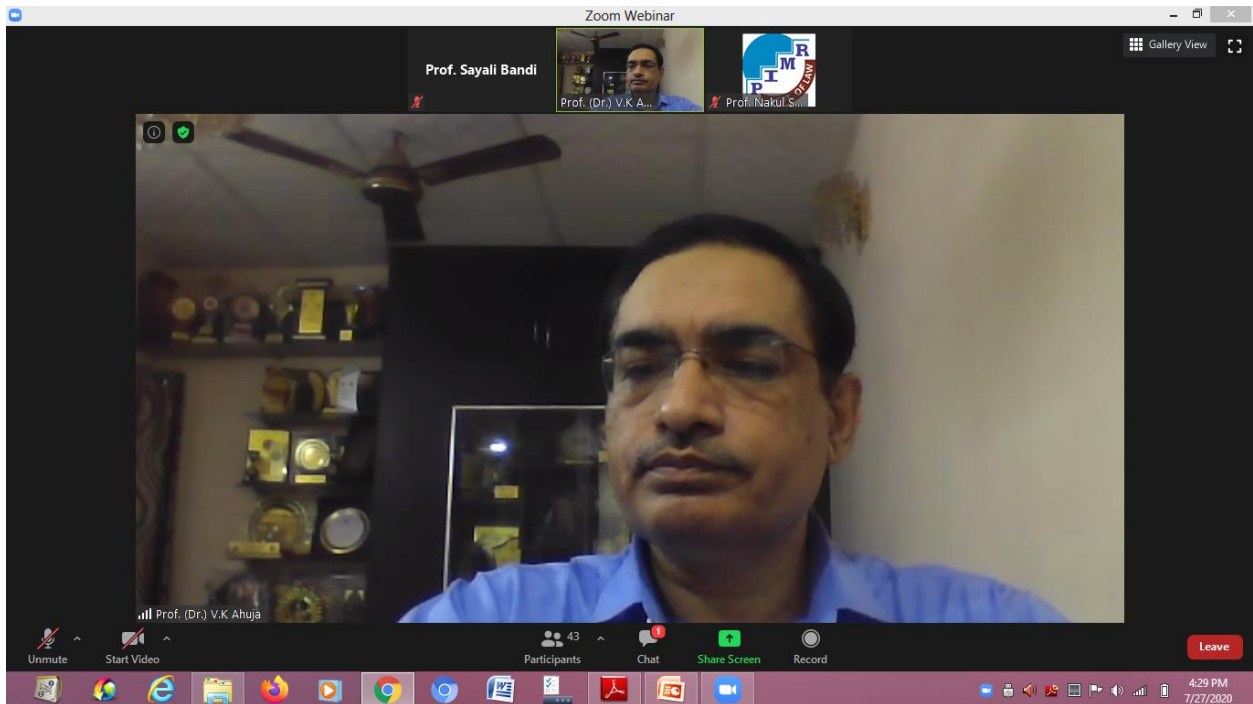

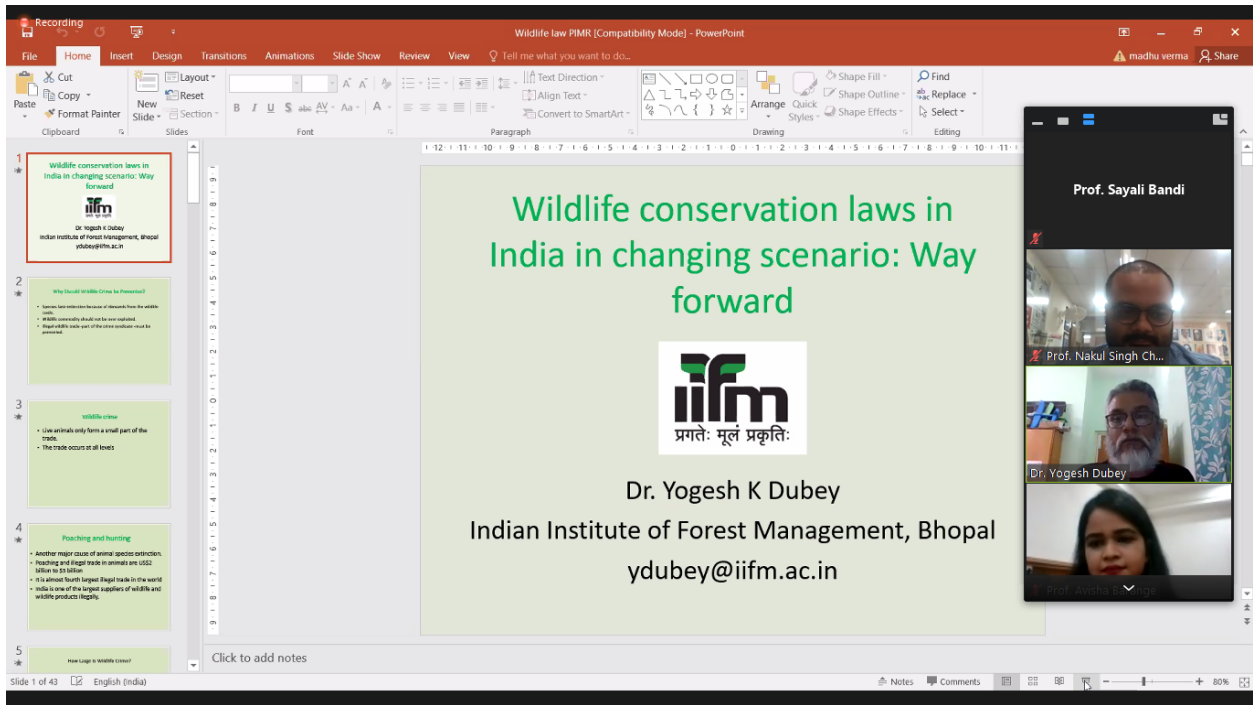

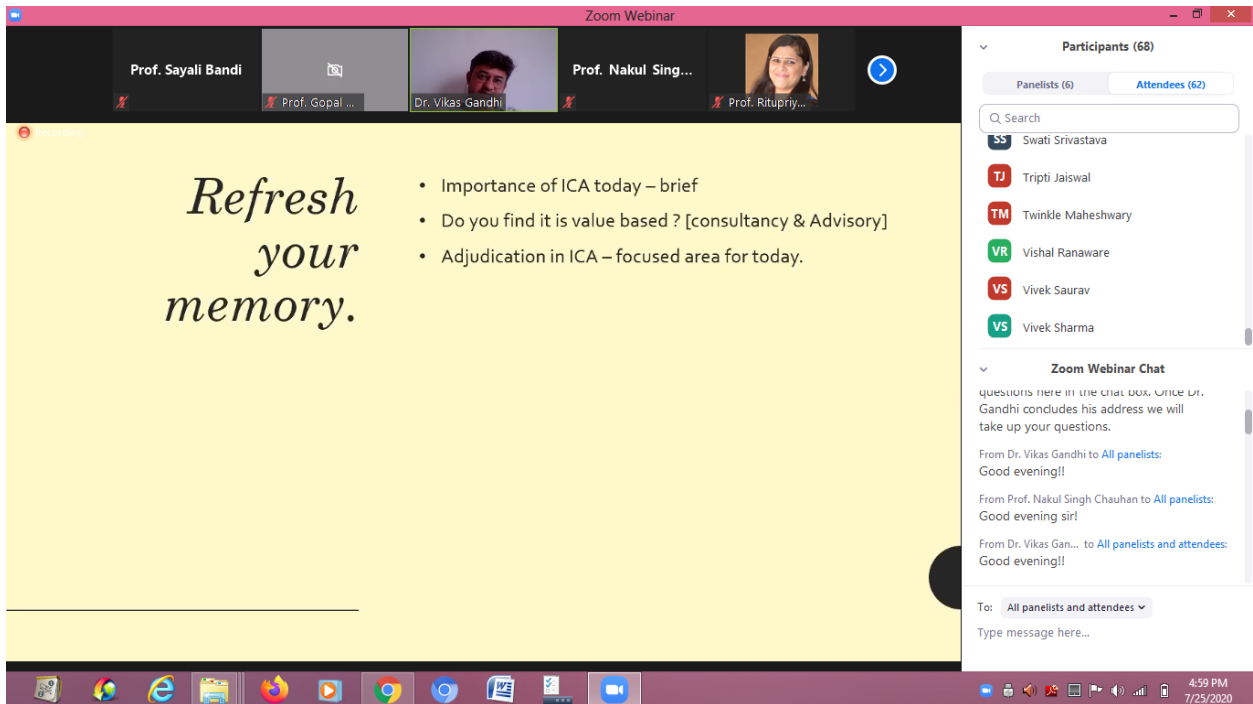
